



I called the phone number and a female answered. The female identified herself as "Sharon". I told her I saw her ad on backpage.com and wanted to schedule an appointment. She stated she was available later in the afternoon. She stated that she owned a non profit dog rescue and had been struggling financially the past three months so she was doing this to supplement her income. I asked her how much her services would cost. She stated that she charged \$120.00 for a half of an hour and \$160.00 for a full hour. She stated that the fee covered everything except "anal". I gave her a randomly selected address of 1530 Santanella Terrace in Newport Beach. She stated she needed to go home and shower first and then she would text me.

At approximately 1547 hours, I received a text message from 714-947-3410 stating she was running late. I responded to the text asking when she would be available. My phone rang and the same female who identified herself as Sharon stated she would not be available until later in the evening. I told her I would text her later if I was available.

At approximately 1834 hours, I sent a text message to 714-947-3410 and asked if she was available. At approximately 1835 hours, I received a text stating that she was "All freshly showered and ready to go". I responded to the text and stated I would be waiting for her at the pre determined location.

At approximately 1845 hours, Sergeant Freeman, Detective Haas, and I established surveillance at 1530 Santanella Terrace.

At approximately 1910 hours, I observed a yellow Ford Escape (CA License 4UVW996) pull onto the street. The vehicle parked directly in front of 1530 Santanella Terrace. A female (later identified as Logan, Sharon) exited the vehicle. I immediately recognized the female as the person in the pictures on the ad. She began to walk up the driveway to the residence. I exited my vehicle and approached her (in plain clothes). I said, "Sharon". She turned toward me and said, "Yes". I identified myself verbally and with my badge as a Newport Beach Police Officer. I asked her if she had a business license or escort permit with the City of Newport Beach. She said, "No". Logan was holding a cellular phone. I asked her if that was the phone she was using to communicate with me. She said, "Yes". I called the phone number and her phone rang. I asked her if she had anything illegal in her vehicle. She said, "No". I asked her if Sergeant Freeman could search her vehicle. She said, "Yes". Two unused condoms were found in Logan's purse. I asked Logan how long she had been having sex with men for money. Logan stated she had been doing this for the past three months. She stated she dated approximately three men a week. I placed Logan under arrest for escorting without a permit and operating without a business license.

I booked the two condoms and her cellular phone as evidence (for further details, refer to Property Report-Same DR). Logan's vehicle was secured and left at the scene at her request.

Officer Hoo transported Logan to NBPD jail where she was booked without incident.
