- S.L. 6. If I am not a citizen of the United States, I understand that this conviction may have the consequences of deportation, exclusion from admission to the United States, or denial of naturalization pursuant to the laws of the United States.

- X 8. I could be committed to a treatment facility for an indefinite period, potentially for life.
- X 9. I will be ordered to register with law enforcement as to my place of residence.
